

Jayride grows coverage to exceed 50% of global airport passenger trips

Jayride Group Limited (ASX:JAY) ("**Jayride**" or the "**Company**") the e-commerce marketplace that allows travellers to compare and book airport transfers from 3,000+ transport companies, is pleased to announce the launch of Jayride in five new countries across Europe and Asia: Germany, Portugal, Belgium, Malaysia and Taiwan.

In under six-months from July to December, Jayride has launched transport around the world, rapidly expanding from five countries to 25 countries, and has nearly doubled the Company's airport coverage from 27% to over 50% of the world's airport passenger trips.



These new countries expand the usefulness of Jayride to travellers, and increase the Company's ability to grow Total Transaction Value (TTV) for years to come.

In this release, Jayride has launched 5 additional countries, 52 additional airports, with 133 new transport companies, growing Jayride's market access by 438 million passenger trips, to a total of 3.9 billion (50.5%¹) of the world's total airport passenger trips.

Jayride is now available for travellers to book airport transfers in Germany (at 25 airports), Portugal (at 7 airports), Belgium (at 5 airports), Malaysia (at 11 airports), and Taiwan (at 4 airports), which includes every airport with greater than 25,000 international passenger trips per year.

At these airports, travellers can now choose the best transfer for them from over 133 private transfer and shared shuttle companies, including great local private car and shared shuttle services, and even popular international transport brands.

They service popular destinations, including:

- Berlin Brandenburg airport to Brandenburg gate,
- Lisbon Portela airport to Belem,
- Brussel airport to Grand Palace,
- Kualu Lumpur airport to Kualu Lumpur tower,
- Taiwan Taoyuan airport to Taipei,

These transport services are now available to be booked by Jayride users.



Continuing international expansion

Jayride's international expansion initiative started in May with the release of Jayride's new transport technology platform. Launches of new countries are successful, accelerating, and expected to continue. Recent significant milestones are summarised below:
